Rules and Regulations

8. In case of change in schedule, the concerned team shall be noticed prior to the scheduled game.
9. In the absence of either team at the scheduled time, the opponent will be announced winner on "walkover basis".
10. Tournament playing condition will be handed to every team Captain /Manager on the day of Tie sheet draws.


